Subject : Second round of Biometric Verification of newly recruited UDC,MTS, Stenographer and SSO (2019 to 2022) of Maharashtra Region – reg

The second round of Biometric verification of newly recruited officials under direct recruitment in the cadre of MTS/ UDC/ Steno./ SSO through recruitment held during the year from 2019 to 2022 (whose Biometric verification could not be done on 11.07.2024 / 12.07.2024) is scheduled to be held at RO Mumbai on 28.01.2025 (Tuesday).

(2) The Biometric verification of the officials posted at RO Mumbai/ SRO Marol/ESICMH Andheri/ PGIMSR Andheri will be conducted at RO Mumbai premises on the above scheduled date.

(5) The Controlling Authority of SRO/Hospital, etc. is to ensure the presence of the officials on the day of the Biometric verification (28.01.2025/ Tuesday) at RO Mumbai and to nominate a Nodal Officer from their office to be present at RO Mumbai on 28-O1,2025 along with their officials of whom verification is to be done and for their identification.

(6) ICT Branch/ General Branch, RO Mumbai is to provide necessary IT support/ Network connectivity/ Seating Arrangement/ etc. of Biometric Verification Team and the officials, as well.
