CIRCULAR

Subject: <u>Seeking options from officials in the cadre of Assistant / Upper Division Clerk</u> / Lower Division Clerk / Multi-Tasking Staff for transfer/posting to SRO- Nagpur and <u>Pune/Nasik/Aurangabad-reg.</u>

There is proposed shifting of Regional Office Mumbai to MGM Hospital, Parel premises and, in order to accommodate the existing staff, reduction in staff inposition at RO is under consideration. Hon'ble CAT, Mumbai Bench, has granted stay on AGT Policy (Intra) and operation of the said policy is on hold. There is acute shortage of staff in SRO Pune/ Nasik/Aurangabad. Number of officials are seeking transfer to SRO Nagpur. Posting of officials in the cadre of Asstt/UDC/LDC/MTS to SRO Pune/Nasik/Aurangabad is under consideration.

(2) In view of above and considering administrative exigencies/requirement, transfer of officials in the above cadre from RO Mumbai for posting to SRO Nagpur and, equal number of officials in above each cadre from SRO Nagpur for posting to SRO Pune/ Nasik/ Aurangabad is under consideration.

(3) Options from the officials of above cadre of RO Mumbai for transfer/posting to SRO Nagpur and the officials of SRO Nagpur for transfer/posting to SRO Pune/ Nasik/ Aurangabad are hereby invited/ called.

(4) The willing officials of the above cadre must have completed 3 years of service at RO Mumbai/SRO Nagpur, as the case may be, as on the closing date of calling option.

(5) The station seniority of the willing official at RO Mumbai/SRO Nagpur, as the case may be, shall be the criteria for consideration for transfer/posting.

(6) The above Transfer/Posting shall be considered in a whole and in public interest. The last date of submission of option from the eligible official is 30.09.2024. The format for submission of options is attached as Annexure 'A'.

(7) Contents of this circular be brought to the notice of all the officials of RO Mumbai & SRO Nagpur. SRO Nagpur/all Branches/ Branch Offices of RO Mumbai shall forward the requests received from the eligible officials to Regional Office, Mumbai, latest by 07.10.2024.

(8) The Authority has, however, reserved the right to cancel and/or restrict the option in the interest of functionality of the Regional Office.
