## <u>CIRCULAR</u>

## <u>Sub:- Mandatory Police Verification for House Helps to</u> <u>Staff Quarters at ESIC Nagar & DCBO Colaba</u>

This is to inform all residents of staff quarters that with immediate effect,**all** House helps / Domestic workers/ Nanny / Tuition teachers and any person regularly visiting or staying in the ESIC Nagar and DCBO Colaba staff quarters must undergo police verification as a security measure.

It is brought to the all concerned that Mumbai is a very sensitive city in view of security point. Recently during the war, the Central & State Govt. have also shown seriousness toward the safety of citizens. To ensure the security of residents & staff & prevent incidents of theft, some security measures are being taken, which are mandatory to follow.

## **Action Required:**

- Ensure police verification is completed for all domestic helpers, maids and any such individual regularly visiting or staying in staff quarters (other than family members).
- Submit a copy of the police verification certificate to the Caretaker's Office no later than 15 days from the date of this notice
- Contract workers should submit identity proof to the Caretaker.
- New hires or visitors must complete verification **before** they begin residing or working in the staff quarters.
- Entry/access for individuals without verification may be restricted after the deadline.
- Visitors have to make entry in register and take entry pass from Security Guard while entering the premises. This pass should be submitted back to Security Guard while exit along with the signature of the resident.

This measure is being implemented to enhance the safety and security of all residents and their families. Your cooperation in this regard is mandatory and highly appreciated.
