1. The declaration by the official regarding the acceptance or otherwise of the promotion offered should be communicated by **22/12/2025**. In the absence of any communication, it will be presumed that they have not accepted the promotion and no correspondence in future will be entertained in this matter.
2. For the officials who are still working in the cadre of Lower Division Clerk (LDC) / MTS should join at the present place of posting, provided they accept the promotion. These officials should be relieved for ordered place of posting thereafter.
3. The Officials who had earlier declined regular promotion to the post of Lower Division Clerk (LDC) on regular basis but subsequently accepted the promotion when offered on next instance and assumed charge of the post and their name is included in this order, their date of regular promotion shall remain same with reference to the date they had taken charge of the promoted post.
4. The date of regular promotion of officials, who are already regular in the cadre of LDC shall be effective from the date of promotion of their respective junior as per the Para 18.4.3 of O.M. No. 22011/5/86-Estt.(D) dated 10.04.1989 and DoPT O.M. No. 2001 I/2/2019-Estt.(D) dated 13.08.2021.
5. The Promotion of the officials, except the officials falling under Para 3 & 4 above, will take effect from the date on which they assume charge of Lower Division Clerk at ordered place of posting.
6. The separate order for actual date of promotion may be issued in due course.
7. The seniority of the official would be determined in the order in which his name has been recommended in the revised panel by the review DPC and in terms of Para 18.4.3 of O.M. No. 22011/5/86-Estt.(D) dated 10.04.1989 and DoPT O.M. No. 2001 I/2/2019-Estt.(D) dated 13.08.2021.
8. The inter-se seniority of the aforesaid officials shall be fixed as per the extant rules.
9. The aforesaid officials promoted from Multitasking Staff (MTS) to the cadre of Lower Division Clerk (LDC) shall exercise their option for fixation of pay within one month from the date of promotion under FR 22(I)(a)(1) and option once exercised will be final.
10. The promotees who have been promoted to the post of Lower Division Clerk (LDC) through LDCE as well as DPC have the option to accept the promotion from either of the mode of promotion and the option once exercised will be final.
11. The regular promotion has been made subject to the terms and conditions of service as applicable to the similar class of employees as laid down in the ESI Corporation (Staff and Conditions of Service) Regulations, 2023 as amended from time to time.
12. The promotion and posting of the officials are ordered in public interest and they are entitled for TA/DA and Joining Time as per rules.
13. The promotion in respect of officials who have been ordered against reserved vacancy will be subject to satisfactory verification of their caste certificate from Competent Authority.
14. The official declining regular promotion will not be considered for regular promotion for a period of one year and will also be passed over, resulting in loss of seniority, as per rules. Moreover, the financial upgradation under MACP scheme of such official shall also be deferred to the extent of period of debarment due to the refusal.
15. The custodian of the Service Book shall make necessary entry/ record in the Service Book regarding acceptance/ refusal of such promotion.
16. Necessary relieving and joining report may be submitted to all concerned immediately.
17. The promotion shall be subject to further orders by the Hon'ble Supreme Court as mentioned in

DOPT, O.M.No. 36012/11/2016-Estt.(Res-I) {Pt-II} dated 15/06/2018.
